

What are Wisconsin's Photo ID requirements for voting?

Most Wisconsin voters must show an acceptable photo ID when voting at the polls on Election Day or by absentee ballot.

Transportation

- <u>Rides to the Polls</u> allows you to search for a ride. All ride information is provided by ADRCs, transportation providers, and other community groups.
- To have your program added to our list, email info@disabilityvote.org. The Disability Vote Coalition does not provide transportation.
- Curbside Voting. If you have difficulty entering your polling place due to disability, curbside voting is required by law. We recommend you contact your clerk in advance of election day to ask how to access curbside voting at your polling place.

Key Rights as a voter with a disability

Right

to vote privately and independently.

Right

to access the polling place.

Right

to use the accessible voting machine at your polling place.

Right

to ask for accommodations, such as a chair to sit in rather than standing in line, signature guide, magnifying glass, assistance stating your name and address.

Right

to assistance marking your ballot (just not your employer or your union representative)



Key Rights as a voter with a disability

Right	to Curbside voting if you cannot go into your polling place as the result of a disability
Right	to bring a "notes sheet" into the polling place
Right	to request another ballot if you make a mistake
Right	to file a complaint if you feel your rights have been violated
Right	to vote as you wish. NO ONE SHOULD TELL YOU HOW TO VOTE!

Guardianship and Voting Rights

- A person under guardianship retains the right to vote unless the court removes it.
- If an individual is under guardianship and unsure of their right to vote, the Court's decision is recorded on a court form called "A Determination and Order on Petition for Guardianship Due to Incompetency."
- A person who has a guardian and has lost the right to vote may petition the court to restore their right to vote.

Voting Absentee

- If you voted absentee, it is too late to return your ballot by mail.
- If you still plan to vote absentee, your completed ballot must be delivered to your municipal clerk's office or your polling place no later than 8:00 PM on Election Day.
- If your community counts absentee ballots at a central location on Election
 Day, return your ballot to the central count location rather than your polling
 place. List of communities that use central count:

- Rules for returning absentee ballots have changed for the April election due to
 a court ruling. You must be the one to return your own ballot. If you are not
 able to return your own ballot because of disability and want to have someone
 else return your ballot, contact your municipal clerk to explain the situation
 and to request a disability related accommodation.

Absentee Ballot Witness Requirement

- You must vote your ballot in the presence of an adult witness.
- The witness can be any adult US citizen except for a candidate on your ballot. A witness can be a friend, spouse, family member, or care worker.
- Seal the envelope in the presence of your witness.
- Have your witness sign the certificate envelope on the line marked "Signature of Witness" and write their **full address** underneath the witness signature.
- Make sure you and your witness complete all information on the envelope so your vote will be counted.

Absentee Ballot Return Assistance - Share Your Story

If the ban on assistance with mailing or returning a ballot will make it difficult or impossible to vote for you, for a family member, or for someone you support, we'd like to hear from you!
